- 1) to know, accept and specifically approve all the norms, none excluded, of the "arina Isola Rossa" Tourist Port Internal Regulations;
- 2) of being full and legitimate owner or co-owner for up to 50% of the vessel / boat described above.
- 3) that copies of receipts of full payment relating to the sums due to the Unione dei Comuni dell'Ita Gallura regarding the previous year to the one referred to in this renewal application are complete, genuine and truthful.
- 4) to be aware that in order to submit this renewal application for the following year it is mandatory to send attached to this form the payment receipts for the current year. In the event of a lack of full payment receipts, the application will not be accepted.
- 5) to be aware and to accept that, in order to preserve the right of the mooring place in the event of vessel/unit change, such change must be previously authorized by the Port Authority. Otherwise, the mooring of the new unit can not be guaranteed.
- 6) to be aware and to accept that in the case of non-occupation of the assigned mooring place, even for long periods, will in any case be held to pay the expected rate of mooring payment.
- 7) to be aware and to accept that the sole contemplated rate reduction is the one relating to the prior submission of temporary renounce for all or part of the summer period, which must be accepted by the Port Authority.
